AKC Best Practices Guidelines for GSP Club of Washington Hunt Test

AKC has established a set of suggested guidelines that may be helpful in planning and attending field events.

GSP Club of Washington is asking all participants, officials, and attendees to follow the guidelines adopted to help keep all safe.

1. We ask that all participants follow local and state guidelines regarding social distancing.
2. Consider wearing a mask when in close proximity to others.
3. Consider wearing disposable gloves. The club will have a box of medium and extra large available to volunteers and officials.
4. Wash hands often. There will be a hand wash station in close proximity to the sanicans for your use.
5. Bring personal hand sanitizer and use frequently.
6. Sanicans will be sprayed with disinfectant and wiped down periodically.
7. Avoid hand shaking and hugs.
8. Avoid touching or petting dogs that are not your responsibility.
9. Bring your own pen or pencil and avoid using common pen/pencil.
10. We will not be hosting any meals to avoid congregating in large groups and avoid sharing utensils. We will have prepackaged breakfast snacks available.
11. We will not have a common hospitality tent or shelter. We will have several shade tents spread through the camping area for small groups to gather. Please practice social distancing in these areas.
12. Please park with sufficient distance between vehicles if possible.
13. Gunners please bring your own gun and chair.
14. Gloves should be used when handling score cards and ribbons.
